### **Technology Device Release Form**

In accepting this Device, I understand that the Device remains the property of the Valley Home Joint School District (the "District"), to which I am being given a limited use access license to utilize for educational purposes in accordance with this release. As such, I acknowledge and agree to the following:

- The District retains sole right of ownership of the device and related peripherals (including but not limited to associated HotSpot). The classroom teacher, or school administration, retains the right to collect and/or inspect the Device at any time and to alter, add or delete installed software, hardware, extensions, or applications. Usage is a privilege and not a right. The user shall hold no security or ownership interest in the Device.
- The user will not modify or delete the Device's settings, applications, extensions, or applications without District consent.
- The Device may not be used to access any sexually explicit or pornographic material. The determination as to whether the Device has been used to access any prohibited material shall be made at the sole discretion of the District.
- The Device may be used to access the Internet from home. The District does not monitor the Internet webpages, files, and other material accessed on the Device when used from home. While filtering is applied to the Device, some inappropriate content may not be filtered. Accordingly, the parent/guardian is responsible for ensuring that anything accessed through the Device is appropriate for the user, and that it does not violate the terms of this Release.
- The Device will be returned no later than the end of this current school year. If the user graduates, is expelled, or otherwise terminates enrollment with the District for any reason, he or she must return the Device to the District immediately, but not more than seven calendar days from the date enrollment with the District is terminated. The District may require the user to return the Device, without notice, at any time and for any reason.
- In accepting the Device, I release the District, as well as the District's employees, officials, volunteers, contractors, or agents from any and all liability or claims related to, arising out of, or connected in any way with my use or control of the Device and its related equipment, including any liability or claims related to, arising out of, or connected in any way with my execution of this release.
- The user shall make the Device available to the District as necessary for purposes of inspection, maintenance, repair, and/or upgrading during the District's normal business hours.
